#### **NEW BUSINESS-**

## RESOLUTION DECLARING AN ECONOMIC REVITALIZATION AREA-

City Planner Jeremy Skinner presented Resolution #2014-07-02 adopting a Declaratory Resolution designating certain areas within the City Limits an Economic Revitalization Area for real and personal property. The request is being made by R&B Investors/Wildman Business Group for property located in the 800 block of South Buffalo Street. Motion made by Councilor Smith approving the Resolution, seconded by Councilor Call, carried by unanimous vote. (Copy attached).

#### MARKET STREET PROJECT-

City Planner gave the Council an update on the Market Street Project. The Indiana Department of Transportation (INDOT) recently announced that Warsaw was awarded \$1,760,000.00 of Federal Highway Administration funds for part of the Market Street reconstruction project from Bronson Street to Hickory Street. The local phase of the project will be from Argonne Road to just east of Bronson Street. Rich Haddad, CEO of K21 Health Foundation was in attendance and announced that the foundation will be making a major investment/grant of \$375,000 for the reconstruction of Market Street including a bike/walk path as a step toward connecting the various trails of the Greenway master plan. The grant is 3-1 matching grant with the local goal of raising \$125,000 in contributions and donations. Mr. Skinner continued his presentation by presenting pictures and diagrams. The Council shared their gratitude to Mr. Haddad and the K21 Foundation and thanked Mr. Skinner for his presentation. (Information attached to minutes).

# REDEVELOPMENT COMMISSION FINANCIAL REPORT/EXCESS AV DETERMINATION-

Mr. Skinner presented financial information for all the Tax Increment Finance Districts (TIF) within the City as well as the Warsaw Technology Park. He outlined projects to be completed over the next several years in the districts as well as the possible costs. He listed other debts, such as bond obligations, along with projected revenue and budget numbers. The information he presented indicated that no excess assessed values should be allocated to overlapping taxing

units which was also approved by the Redevelopment Commission earlier in the day. The council acknowledged the report and Councilor Smith made a motion to approve the "Excess Assessed Value" determination for the Redevelopment Northern TIF, Redevelopment Eastern TIF, Redevelopment Allocation, and Redevelopment TIF Winona Interurban districts, seconded by Councilor Call, carried by unanimous vote.
